WHAT SHOULD I KNOW?

Before the integration course begins, the course provider will carry out a placement test. The result helps them to decide which course level you should start with and whether a special integration course would be useful.

DO I HAVE TO PAY FOR THE BUS TICKETS MYSELF?

Those who are exempt from costs and live at least 3 km from the course location will receive a travel allowance.

HOW IS THE INTEGRATION COURSE STRUCTURED?

PART 1: LANGUAGE COURSE

The language course is part of the integration course. It lasts a total of 600 teaching units (UE) in the general integration course. The language course covers important topics from everyday life, for example:

- · work and profession
- · education and training
- · childcare and education of children
- shopping/trade/consumption
- · leisure time and social contacts
- · health and hygiene/human body
- · media and media use
- housing

You will also learn how to write letters and emails in German, fill out forms, make phone calls and apply for a job.

The language course concludes with the "German test for Immigrants" ("Deutsch-Test für Zuwanderer, DTZ), i.e. the B1 level of the Common European Framework of Reference for Languages (CEFR).

PART 2: ORIENTATION COURSE

Following the language course, you will attend the orientation course. It comprises 100 teaching units (TU). In the orientation course you will talk about, for example:

- the German legal system, history and culture
- · rights and duties in Germany
- · forms of living together in society
- values that are important in Germany, for example religious freedom, tolerance and equal rights for women and men.

You complete the orientation course with the final test "Living in Germany" ("Leben in Deutschland", LiD).



Persons who have a certificate of eligibility are entitled or obliged to participate. These include:

- ethnic German repatriates
- EU citizens
- · Foreigners with a residence permit
- · German nationals with a need for integration
- · Asylum seekers with good prospects of staying

Please seek advice as to whether you are eligible. We will be happy to help you with your application.

WHAT DOES AN INTEGRATION COURSE COST?

With a certificate of eligibility, the course fee per module costs (= 100 lessons) € 229.00.

Integration courses are free of charge on application

- if you are obliged to attend
- · if you receive ALG II, social assistance
- in the event of economic/personal hardship
- for asylum seekers with good prospects of staying
- for repatriates

Participants with a certificate of eligibility but without cost exemption can apply for a refund of half of the cost contribution after successfully passing the final test within 2 years of the certificate of eligibility being issued.
